

CONTRACT FORM

PURE PERSIAN KITTEN — PURCHASE & HEALTH GUARANTEE AGREEMENT

This Purchase & Health Guarantee Agreement is made and entered into as of the date of the last signature below, by and between Pure Persian Kitten (“Breeder”) and the undersigned purchaser(s) (“Buyer”), collectively referred to as the “Parties.”

Kitten Description

The kitten subject to this Agreement is a Purebred Persian Kitten with the following details (collectively, “Kitten”):

Purchase Price and Reservation

The total purchase price for the Kitten is \$_____. A refundable reservation fee of \$360 (“Reservation Fee”) is required to hold this Kitten for the Buyer once selection is made. This Reservation Fee will be credited toward the total purchase price. The Reservation Fee secures the Kitten exclusively for the Buyer and confirms the Buyer’s commitment to the purchase.

The remaining balance of the purchase price, including any applicable sales tax, transportation costs, health certificate fees, or other agreed charges, is due in full prior to release of the Kitten for pickup or delivery. The Buyer agrees that no Kitten will be released until all payments have been received and cleared by the Breeder.

Payment Methods

Payments may be made by methods acceptable to the Breeder, such as bank transfer, cashier's check, Zelle, PayPal, Chime, Cashapp, or other mutually agreed platforms. All fees associated with payment processing are the responsibility of the Buyer.

Pickup and Delivery

Once the Kitten reaches the appropriate age and has completed all required veterinary care, including vaccinations and health checks, the Breeder and Buyer will agree on either a pickup date or delivery arrangement.

- Pickup: The Buyer or a designated representative may pick up the Kitten at the Breeder's designated location on an agreed date.
- Delivery: If requested, the Breeder will coordinate delivery to the Buyer's home, nearest major airport, or another agreed location. Delivery arrangements and associated costs are the responsibility of the Buyer unless otherwise agreed in writing.

Health and Veterinary Care

The Breeder warrants that, to the best of their knowledge as of the date of transfer, the Kitten is in good health, has received age-appropriate vaccinations and deworming, and has undergone standard veterinary checks. The Breeder will provide detailed health records, including vaccination and deworming documentation, at the time of pickup or prior to delivery.

Health Guarantee

The Breeder provides a limited health guarantee that the Kitten is free of serious congenital or hereditary defects at the time of transfer. To validate this guarantee:

1. The Buyer must have the Kitten examined by a licensed veterinarian of their choice within 72 hours of possession (excluding weekends and holidays).
2. If the veterinarian determines the Kitten has a life-threatening congenital defect that existed prior to transfer, the Buyer must submit a written report on official veterinarian letterhead identifying the condition.

3. The Kitten may be returned to the Breeder at the Buyer's expense, and the Breeder may, at Breeder's discretion, replace the Kitten with one of similar quality of equal value if available.

The health guarantee does not cover illness or conditions arising after the kitten leaves the Breeder's possession, nor veterinary expenses incurred after the sale. The Buyer is responsible for all veterinary care following the initial examination.

Buyer Responsibilities

The Buyer agrees to provide:

- A suitable indoor environment, with adequate food, water, shelter, and sanitation.
- Routine veterinary care for the lifetime of the Kitten.
- Prompt veterinary treatment if the Kitten shows signs of illness or injury.
- Continued vaccinations and health maintenance according to standard veterinary practice.

The Buyer agrees that the Kitten will remain an indoor pet only unless otherwise agreed in writing, and will not be placed in a shelter, pet store, laboratory, or similar facility without prior written approval from the Breeder.

Transfer of Ownership

Ownership of the Kitten transfers to the Buyer upon full payment of the purchase price and any additional charges, and once the Kitten has been officially released to the Buyer or the Buyer's agent.

Refund Policy

Pure Persian Kitten strives to provide happy and healthy kittens to all buyers. If for any reason the Buyer cannot proceed with the purchase before the kitten is released, the Buyer may request a refund of the reservation fee. Refunds will be issued within 7 business days via the original payment method.

If the Kitten is found to have a life-threatening congenital or hereditary condition within 72 hours of veterinary examination after release, and the Breeder confirms the defect, the Buyer may return the Kitten to the Breeder for a full refund of the purchase price, including the Reservation Fee, or request a replacement kitten of equal value if available.

Governing Law

This Agreement shall be governed by the laws of the state of _____, and any disputes shall be resolved in the courts of that jurisdiction.

Entire Agreement

This Agreement constitutes the entire understanding between the Parties concerning the sale and transfer of the Kitten. No oral statements or prior agreements shall have any force or effect.
